PAUL G. BABAKITIS **President**

Paul began his venerable career with over two decades of distinguished service with the NYPD. Throughout his tenure, he undertook a variety of assignments, including Patrol, OCCB, and other investigative and supervisory roles. Along the way, he garnered many accolades and is proud of his numerous accomplishments.

As the technology advisor to the Chief of Personnel and Deputy Commissioner of Technology, Paul pioneered the introduction of numerous groundbreaking technologies to the NYPD, most notably, a handheld computer device that revolutionized the Force. This device granted field officers instant access to critical information from a variety of local, state, and federal law enforcement databases, and in so doing, significantly increased efficiency and enhanced public safety. For his vision, innovation, and introduction of this new technology and its impact, Paul was honored by the New York City Police Foundation, receiving the prestigious Dale Hemmerdinger Award for Police Excellence. This recognition marked a historic moment for the Foundation, as no other member of law enforcement had been recognized for having such a profound impact on improving the effectiveness of law-enforcement.

After serving 22 years with the Department and retiring from the NYPD in 2004, Paul became a licensed private investigator in 2006 and established a leading-edge Private Investigations firm that harnessed new and emerging technologies to capture and preserve credible evidence. The Wall Street Journal recognized Paul's innovations for bringing credibility to video technology to the Housing Court. His firm quickly expanded, and he obtained licenses to provide private investigative services in New York, New Jersey, and Florida. During this time, Paul joined the Society of Professional Investigators, actively participating and contributing to the organization's monthly meetings.

Paul has always been motivated by innovation. He is credited with being the first to recognize the need for officers to access law-enforcement databases in the field and on the fly. Since that time, several law enforcement agencies have expressed interest in utilizing his device, showcasing the impact of Paul's ability to integrate new technology in furtherance of advancing new investigatory techniques. While Paul's career is chock full of interesting cases, perhaps none is as well-known as the harrowing incident on a commercial airline when a deranged pilot made a concerted effort to crash the plane. Paul's skill set and exercise of good judgment were put to the test as this potential tragedy unfolded before him (he was a passenger on the flight). Paul assessed the situation and leaped into action, assisted by two other passengers, to stop the person who happened to be the pilot. Paul's actions were credited with averting disaster by keeping all 130 passengers safe while the plane made an emergency landing. For his actions, Paul garnered worldwide attention, attributing his training with the NYPD for enabling him to tactically handle the situation.

In September 2021, Paul ascended to the presidency of the Society of Professional Investigators, marking the first time in over 20 years that a former member of the NYPD took the helm of one of the World's most prestigious private investigation organizations. As president, he rebranded the organization and implemented innovative strategies to attract qualified members who could collaborate on compelling cases and form valuable connections.

Daniel is a Senior Detective with the New York City Office of Special Narcotics Prosecutor, which investigates Major Case Drug Trafficking organization throughout New York and there ties to the cartels. In his almost 19 years in law enforcement, he has played many roles. 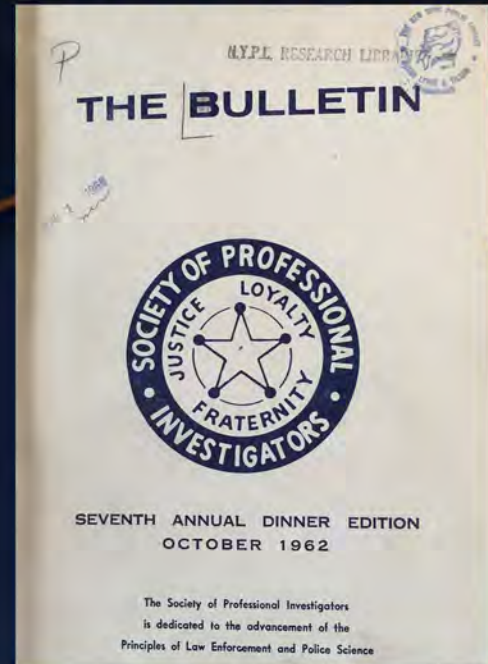
Jason Bass

In 1955 in the midst of the Cold War and at a time when crime was adversely affecting the lives of all Americans, several men came together to form an organization dedicated to professionalize law enforcement, especially in the metropolitan area. These men (and they were all male at that time) wished to, among other goals, “cultivate and advance knowledge of the science of investigations, promote the efficiency of the investigator in the services he (sic) performs and develop a spirit of mutual understanding of their respective problems, duties and obligations as professional investigators.”

Who were these men? They were former members of the Office of Strategic Services (the OSS), the precursor to the Central Intelligence Agency (the C.I.A.), most of whom had migrated into law enforcement in the post-war years. In July of 1956, the Society of Professional Investigators, Inc. (S.P.I.) was duly incorporated.

As we gather to celebrate our sixty-fifth Annual Gala, we also celebrate how the Society of Professional Investigators has evolved since 1956. Currently, our organization now includes numerous women, among them several serving as officers and directors of the Society. We also have numerous female members, both active in and retired from law enforcement and intelligence agencies.

In addition to those in law enforcement and intelligence communities, our Society's membership includes private investigators, attorneys, certified fraud examiners, certified public accountants, and other highly qualified people. Our membership encompasses not only individuals in the Metropolitan area but many living out of state and outside the United States.

The Society is renowned for the expertise of the various investigative experts to speak at its monthly meetings. These presentations have included topics such as polygraphy, open-source intelligence, the rules of evidence, and other forensic topics. These meetings also provide excellent networking opportunities. S.P.I. also maintains close relationships with numerous other law enforcement and private sector investigative professionals and fraternal organizations.

Although none of our founding members from over sixty-five years ago are still with us, their dedication to professionalism in law enforcement lives on and will continue to thrive throughout the future. The Society's original motto of “Justice, Loyalty and Fraternity” is as

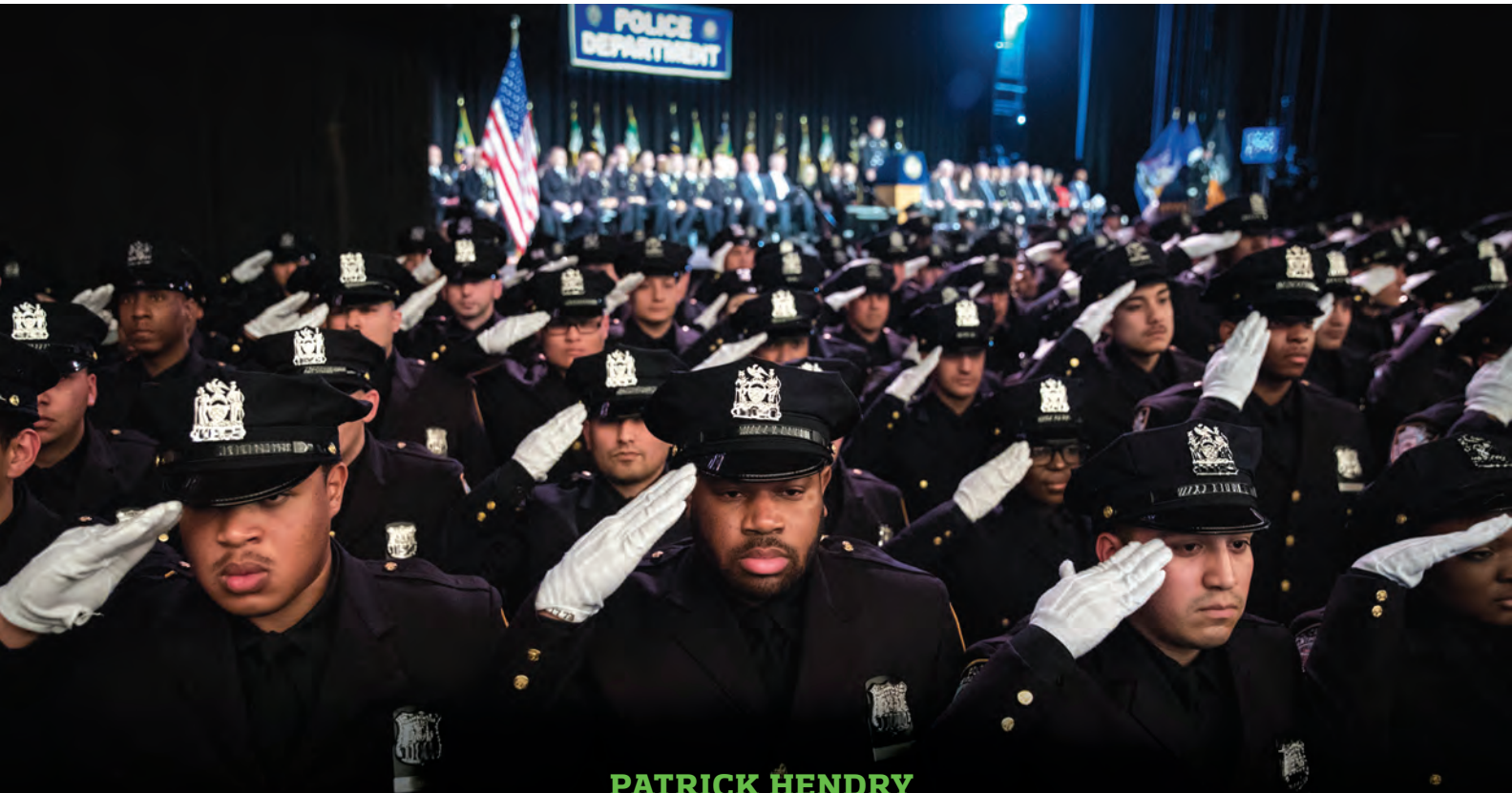

GIUSEPPE "JOSEPH" PETROSINO**

End of Watch March 12, 1909

Lieutenant Petrosino founded the agency's Italian Squad, which was responsible for investigating the Italian mafia in New York City and was responsible for decreasing Italian mafia crime by fifty percent. He was sent to Italy in an attempt to infiltrate the mob and collect evidence that would shut them down for good. The mafia received a tip that he was a police officer and killed him. Lieutenant Petrosino had been with the New York City Police Department for 25 years. He was survived by his wife and daughter.

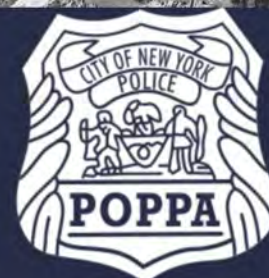
